Noel reported that at the O/60's AGM it was decided that "a side or team will consist of two rinks, of 3 players per rink. #### **General Business:**

- 1. Review of changes made to the 2021/22 season.
  - a. Pennant Selection committee/s. Changed from 2 autonimous committees to 1 committee. Then altered to 2 sub-committees under 1 Selectors Chairman. After much discussion we decided to put to the members at the AGM having an over-riding selection committee of the Coach & 2 members. These 3 would instruct 2 selection sub-committees, a mid-week & a weekend, as to player development and planned direction. The 2 sub-committees would them act on such and select teams.
  - b. Number of committee members. (Deleted for 2021/22 season.)
    - i. Junior VP. To remain as 'deleted.'
    - ii. Past President. Take to AGM to reinstate this position.
    - iii. 3 'spare' positions. We have the ability to Co-Opt if needed.
    - iv. Mens & Ladies Match altered to 1 position. To remain as 1 position.

- c. Number of committee members. (New for 2021/22 season.)
  - i. Asst. Sec. Was a success: continue.
  - ii. Asst. Treasurer. Was a success: continue.
- d. Deadlines for rounds of club games. Was a success: continue. But look to having 1<sup>st</sup> rounds & maybe 2<sup>nd</sup> rounds on a dedicated day, especially pre-season. Limited leniency will be allowed for play after deadlines provided all parties agree, prior notice is given & the reason is NOT 'minor.'
- e. Implementation of procedures and policies. *Members are bound by them and need to familiarize themselves with them. The committee will enforce them.*
- f. Terang club representation & bar running proposals. Terang BC members need to take up representation on the Terang Club committee.
- g. New uniforms. Successful.
- h. New BBQ area. Successful, with further development to come.
- i. How about a new club event? Mixed pairs. To be put to the members at the AGM to run this as a new annual single entry event with honour board and prize.
- j. Do we want our weekend division 1 team to be relegated? *No*.
- k. Coach & role thereof: Suggested Denis Delaney with 2 assistants: Kevin Lee & Margaret Sumner to be approached. *Agreed. Role statement to be developed.*
- 1. The role of managers. *Follow role statement*.
- m. 2022/23 pennant structure. (Requested by WPA.)
  - i. 21 or 25 ends. 25.
  - ii. A mid play break. Yes.
  - iii. Governance options. Option 'C' as this is the only one that allows club input.

- **o.** Delegates to put to WCR that some of their events could be a Champion of Champion style like the 'A' grade; what about triples, fours etc. This would free up days for clubs.
